Risks LDC's are facing

- ▶ **Excavation Damages to distribution facilities, due to:**
 - ▶ No pre-planning/design thus not accounting for location of existing facilities
 - ▶ Inability to locate plastic gas lines with conventional locate equipment
 - ▶ Excavation within prescribed Tolerance Zones using mechanized equipment
 - ▶ Irresponsible use of Trenchless Technologies
 - ▶ Responsible Project Ownership
 - ▶ Damages that are the result of the Excavator not notifying One Call
- ▶ **Legacy Cross Bores**
 - ▶ Incidents related to drain clearing activities (plumbers/DIY's/public)

Damages #1

- ▶ **Multi - Project Coordination Tools (software)**
 - ▶ Incorporate multiple facility owner projects in a common GIS based tool
 - ▶ Provides for regional synergies driving potential cost savings and less disruptions to the public
 - ▶ Planning, designing, bidding, permitting & construction
 - ▶ Opportunity to promote greater degree of S.U.E.



Damages #2

- ▶ **Plastic Pipe Locating/Tools & Capabilities on Gas Distribution Systems**
 - ▶ Jameson Gas Service Line Tracer Kit
 - ▶ Jameson Gas Main Line Tracer
 - ▶ Bi-directional camera for PE facilities
 - ▶ Acoustical line locating i.e. MADE SA
 - ▶ Ground Penetrating Radar (needs HELP)



Damages #3

▶ Enhanced Positive Response

- ▶ Provides Excavator with verification with what was field marked for their request, so eliminates misunderstandings
- ▶ Includes One Call Center so their position as source for information is supported
- ▶ Increases Excavator – Facility Owner communications
- ▶ Promotes accountability
- ▶ Creates a shared responsibility environment



Damages #4

▶ Drone utilization:

- ▶ Document site conditions on a post mark out basis which provides accountability and potential behavior changes
- ▶ Potential to eliminate tolerance zone management and minimize damages to mismarked facilities
- ▶ Surveillance potential for critical facilities or problem excavators



Damages #5

▶ Highway Electronic Message Boards

- ▶ Uses existing infrastructure in place across the country in high traffic and high visibility locations
- ▶ Does not compete with core messages (off peak messaging)
- ▶ Promotes 811 awareness
- ▶ Programmable for seasonal and target audience outreach



Damages #6

▶ No One Call Reporting Program

- ▶ Provides for a call to 811 to report an excavation site where no paint, flags or markings are present
- ▶ Integrates into the One Call Emergency Ticket structure
- ▶ Uses smart phone to access Tickets Nearby Tool to confirm tickets in proximity to site (GPS).
- ▶ Prevents damages and promotes 811 awareness
- ▶ Creates the opportunity to involve employees in an incentive based rewards program
- ▶ Changes excavator behavior

Legacy Cross Bores #1

- ▶ **Call Before You Clear - Notification system**
 - ▶ Addresses prior damages by trenchless technology installations
 - ▶ Provides a safety net for drain clearing community
 - ▶ Reduces incident potential on gas distribution systems
 - ▶ One stop approach to supporting potential cross bore sites
 - ▶ Potential to integrate with existing One Call systems



Legacy Cross Bores #2

- ▶ **Bio-degradable locate balls**
 - ▶ Provides for locating previously non-locatable sewer lines
 - ▶ Locates completed using conventional electronic locators
 - ▶ Environmentally friendly
 - ▶ Does not require excavation or sewer line entry
 - ▶ Reduces cross bore potential


