Task Team 1 Goals

Determine if there is consensus on best practices for:

- 1. Defining recommended [characteristics] of land use adjacent to transmission ROW.
- 2. Using enhanced building codes for structures adjacent to transmission ROW.
- 3. Simple, risk-informed guidance for 1. and 2. above. This guidance should be based on attributes of both the pipeline and the proposed development.

4. Model Ordinances, Planning Policies, Regulations, or State Legislation incorporating or promoting any of these best practices.

- Practices Focusing on "Protecting People"
- Practices Outside Pipeline ROW
- Should not Focus on Emergency Planning (except as it affects planning)
- Communicating Risk to Communities is required for riskinformed decision making
- Early Consultation Important
