Specific Objective(s) of the Agreement

Under this grant agreement, the IUB will:

- • Foster support and partnership with stakeholders
- • Support a Damage Prevention Education Program for industry stakeholders

Workscope

Under the terms of this grant agreement, the Grantee will address the following elements listed in 49 U.S.C. §60134 (b) through the actions it has specified in its Application.

- • **Element 2 (Comprehensive Stakeholder Support):** A process for fostering and ensuring the support and partnership of stakeholders, including excavators, operators, locators, designers, and local government in all phases of the program.
- • **Element 4 (Effective Employee Training):** Participation by operators, excavators, and other stakeholders in the development and implementation of effective employee training programs to ensure that operators, the one-call center, the enforcing agency, and the excavators have partnered to design and implement training for the employees of operators, excavators, and locators.

Accomplishments for the grant period (Item 1 under Agreement Article IX, : “A comparison of actual accomplishments to the objectives established for the period.”)

Element 2 (Comprehensive Stakeholder Support) and Element 4 (Effective Employee Training):

All goals under these sections were accomplished. A two-day damage prevention summit was held April 29-30th, 2014, at no charge to attendees. The summit provided an optimal forum for all stakeholders to work together cooperatively to find ways to reduce unnecessary damages to Iowa’s infrastructure. For the first time we were able to secure two well-known speakers to increase attendance and state wide interest in our efforts to hold a quality damage prevention summit. Workshops were held on the first day for CPR/First Aid, Trenching and Shoring Competent Person, Utility Locate 101, and a locate rodeo. The second day offered educational sessions to raise damage prevention awareness, legislative roundtable, and vendors. See attached program.

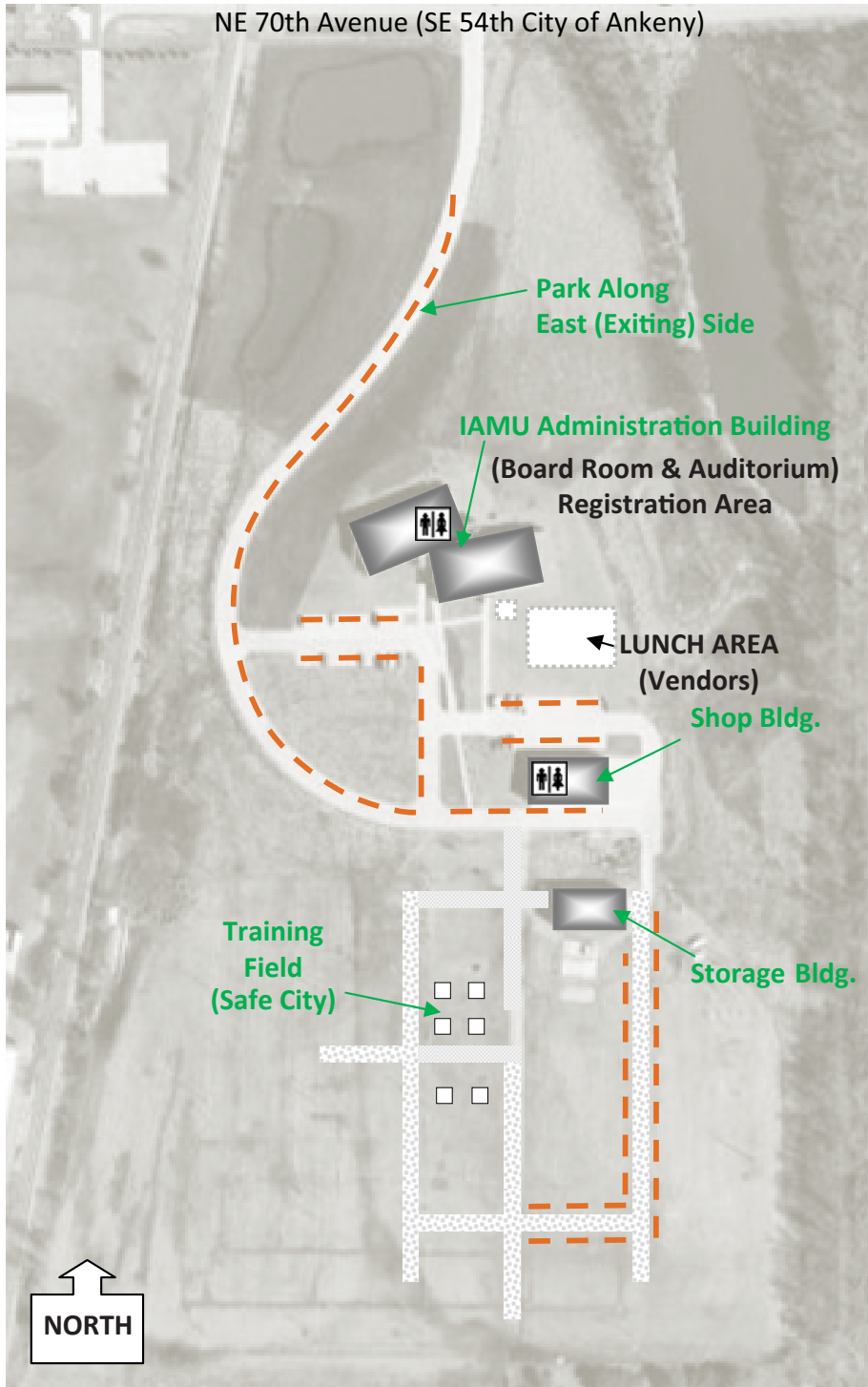

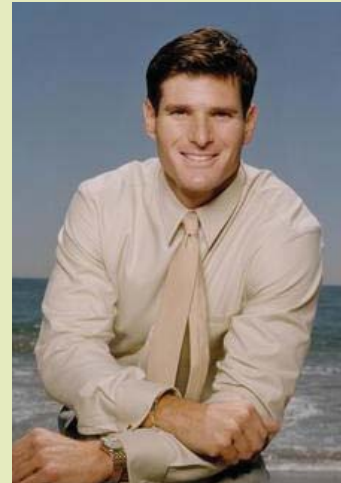


Eric Giguere

Who Should Attend

Contractors, Excavators, Utility Personnel, Public Works Directors, Municipal Engineers, Project Engineers, Project Architects, Insurance, and anyone who works with public and/or private infrastructure. The session will cover American Red Cross certification objectives for CPR the use of AED's and basic first aid.

Session Highlights

The purpose of this session is to meet the OSHA regulations in providing first aid to employees. It is also the aim of this class to make the employees are more aware of how people get injured which should help keep them on the job and increase their productivity.

Participants will learn the following competencies:

- Identify ways to prevent injury and/or illness
- Recognize when an emergency has occurred
- Follow three emergency action steps in any emergency

Excavators, contractors, utility personnel and/or their contractors, and ultimately the person who has the responsibility for the control of the excavation site. This session will address soil classifications, protection systems and evaluating the dangers of the trench.

Session Highlights

OSHA requires that a competent person be on-site at every excavation. The competent person is required to evaluate site safety and resolve existing and potential hazards. This workshop is an excellent opportunity to become a competent person (or stay current with the responsibilities). The workshop is designed for city and utility employees, contractors and excavators. The training received will cover the overall requirements of the law, including: employee safety, soil identification, emergency equipment, determining if shoring is needed, and proper methods of trenching and shoring.

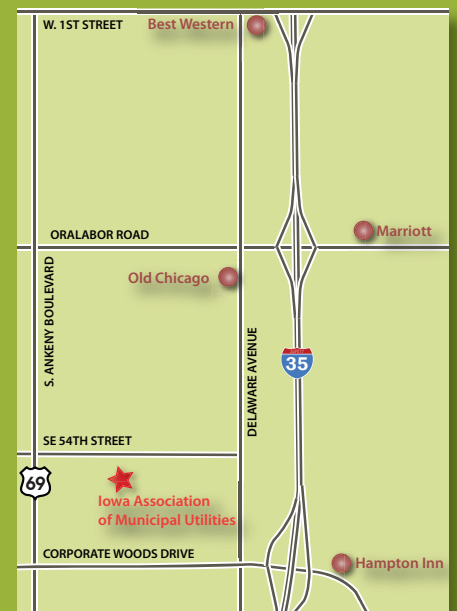

ASCE 38-02 Standard Guideline for the Collection and Depiction of Existing Subsurface Utility Data – Who, What, When and Where?

In 2001 Snyder & Associates began to apply the SUE process on projects where the owners saw benefit. In 2007 John became a founding member of Common Ground Iowa (CGI) and has been a part of the executive team since its inception stepping down in December 2013. John was a member of the Iowa One Call Board as a Class B Director from April 2012 through April of 2014. John is also a member of Common Ground Nebraska (CGN) and is active pursuing safe effective ways when working around underground infrastructure.

Session Highlights

The Minnesota Office of Pipeline Safety investigates excavation related damages. Each year in a significant number of the investigations, how an underground facility was marked and interpreted was a factor in the damage. The misinterpretation of the marks often occurs because the excavator is less familiar with marking standards than the locator assumed. In many of these situations the marks were not the primary cause of the damage, in fact, often the marks were not in direct violation of any excavation law. If the person responsible for locating the facility had considered how the marks might have been interpreted, they may have chosen a different method of communicating. This presentation will give the audience a different perspective and approach to marking facilities and explore methods or solutions to enhance this form of communication. The speaker will use several real life examples to convey the message.

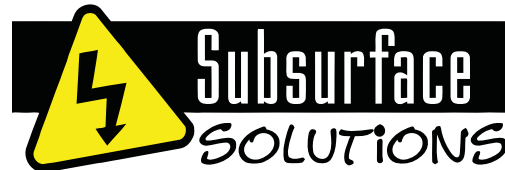

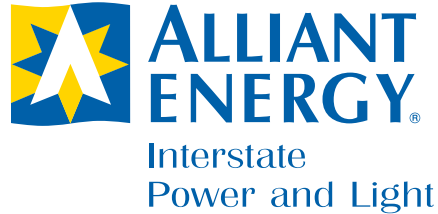
