Specific Objective(s) of the Agreement

Under this grant agreement, the KCC will:

Use the costs for one full-time employee for inspections and enforcement in the Wichita and Kansas City metropolitan areas.

Workscope

Under the terms of this grant agreement, the Recipient will address the following elements listed in the approved application as stated in 49 U.S.C. §60134 (b).

 Element 7 (Enforcement): Enforcement of State damage prevention laws and regulations for all aspects of the damage prevention process, including public education, and the use of civil penalties for violations assessable by the appropriate State authority.

Accomplishments for this period (Item 1 under Article IX, <u>Section 9.01 Progress Report</u>: "A comparison of actual accomplishments to the objectives established for the period.")

Enforcement Activities under Element 7:

A full time damage investigator provided education and enforcement of KUUDPA during the grant period. The investigator developed a rapport with operators and excavators in the field and through participation in various regional and city committees and groups. Time was spent educating new excavators and operators on damage prevention laws, answering questions and providing resources and materials for future reference. Damage investigations were performed not only onsite in the metro and surrounding areas, but "offsite" as well. There were 567 damage investigations completed in this grant period including those outside the metro areas or "offsite". Offsite investigations expand the area for regulatory enforcement. The two largest natural gas public utilities are required to promptly notify the KCC of any third party damage to a pipeline. Upon this notification of a damage outside the metro area, the investigator reviews the information provided, the database for a valid locate ticket then makes contact with the operator and/or excavator to determine if there exists a probable violation of KUUDPA. This additional contact with excavators and operators across the state has increased

awareness of damage prevention laws and accounted for 18% of all damage investigations in this grant year. In addition to investigating damages shortly after they occur, the investigators made random site visits to conduct locate ticket audits to assure that tickets were completed by the due date and that lines were marked within the scope of the ticket. This has been an excellent enforcement tool to ensure the utility operators are meeting their obligation in the constant struggle to get all facilities marked on time.

Data reflecting enforcement activity is shown below. This chart provides data specifically for KC metro and Wichita, which are Kansas' most populated areas. Offsite investigation data is also shown.
