Specific Objective(s) of the Agreement

Under this grant agreement, the MPSC will

- Support a Damage Prevention Education Program for industry stakeholders
- · Support Public Awareness and Stakeholder Education
- Foster and promote the use of improving technologies

Workscope

Under the terms of this grant agreement, the Recipient will address the following elements listed in the approved application as stated in 49 U.S.C. §60134 (b).

- Element 4 (Effective Employee Training): Participation by operators, excavators, and other stakeholders in the development and implementation of effective employee training programs to ensure that operators, the one-call center, the enforcing agency, and the excavators have partnered to design and implement training for the employees of operators, excavators, and locators.
- Element 5 (Public Education): A process for fostering and ensuring active participation by all stakeholders in public education for damage prevention activities.
- Element 8 (Technology): A process for fostering and promoting the use, by all appropriate stakeholders, of improving technologies that may enhance communications, underground pipeline locating capability, and gathering and analyzing information about the accuracy and effectiveness of locating programs.

Accomplishments for this period (Item 1 under Article IX, <u>Section 9.01 Progress Report</u>: "A comparison of actual accomplishments to the objectives established for the period.")

Element 4 (Effective Employee Training): This has not been addressed in this period.

Element 5 (Public Education): MPSC has partnered with Mississippi 811, Atmos Energy, CenterPoint Energy and Comcast Cable to support 7,101 on air cable ads and 390,000 xfinity.com and foxnews.com ads promoting the "Call Before You Dig" message during 2014 - 2015. This message is expected to be seen by over 216,000 households in Mississippi.

During this campaign, 2 new member utilities have been added to Mississippi 811 and during the period of January 1 – April 30, 2015, call volume has increased 1.9%.

Element 8 (Technology): By providing hands on training and promoting the D.I.R.T. tool, we are collecting data in a consistent manner to identify the areas of weakness in our existing program, and will then share it with the MDPC Board for analysis with an emphasis on identifying root causes of damages and other useful trends.

Mississippi 811 had a D.I.R.T. form that could be completed on their website, but it was not compatible with the CGA on line D.I.R.T. report. That had to be changed and a link directly to Mississippi's D.I.R.T. form on the CGA website was added, but still allowed Miss 811 to access the information. Then hand-outs were developed to provide education on the D.I.R.T. report and promote entry of the information. Meetings were held with the 3 major gas distribution companies to encourage data to be entered through Mississippi's virtual D.I.R.T. One company is currently entering data through Mississippi's D.I.R.T. and efforts are being made by the other 2 companies. The initial effort centered on gas utilities, but it has been expanded to include water and electric utilities.

In March 2015, a booth was set up at the Mississippi Rural Water Annual Meeting and two breakout sessions allowed for explaining the benefits of participation. 25 packages were given to participants at the booth who specified that they would be the person to enter damage data.

10 companies have registered to start entering damage data and others have made verbal commitments.

We expect all aspects to be completed by the end of the grant period.
